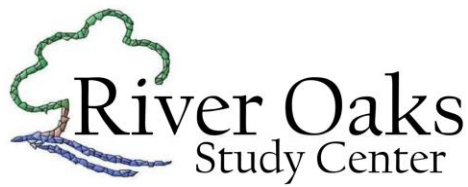
NON-NEGOTIABLE RULES
